Limited Warranty

To original purchaser:

Mekala will provide warranty coverage against:

- Frame weld cracks, splits or breaks for 5 Years
- Frame finish peeling, flaking or blistering for 5 Years
- Strap breakage for 3 Years

Items not covered

Under this warranty include:

- Discoloration of vinyl straps
- Scratching of frames
- Damage caused by misuse, abuse, vandalism or Acts of God
- Freight or transportation to the factory after one year
- Acrylic or fiberglass tops
- Failure caused by neglect of normal care and maintenance

Care Instructions

- To maintain the appearance of your furniture, some periodic care and maintenance is necessary. For maximum life and best appearance, wash furniture on a weekly basis. Most dirt and stains can be removed with mild detergent and water. Rinse off with a hose; then clean (as you would an automobile) with a bucket of soapy water and a sponge or soft towel. Rinse soap off thoroughly and dry with a towel or chamois.
- Remove stubborn stains with non-abrasive cleansers such as Soft-Scrub. Use of more aggressive cleansers or solvents is not recommended and may damage the paint or vinyl.
- Clean vinyl straps frequently, as many sun blocks and lotions can cause permanent discoloration if not removed quickly. Use of a beach towel over the vinyl will prolong strap life.
- Tend to small scratches in frame finish, as soon as noticed, with touch up paint. Our frames are all-aluminum and will not rust; however, moisture penetration through scratches can cause paint blistering, particularly near the ocean.
- Approximately twice per year, apply a coat of automobile cleaner/polish to restore finish and keep your furniture looking new.

Please Note: In cases where straps have to be removed for sandblasting and repainting, customer will be charged for new straps.

Warranty is valid for the original purchaser only and claim must be accompanied by proof of date of purchase and original invoice number. Mekala Powdercoat & Patio Mfg., at its discretion, will repair or replace the defective part free of charge. Mekala Powdercoat & Patio Mfg. shall not be liable to the purchaser or to any other person for any incidental or consequential damages or loss of profits resulting from the use of, or any defect in, or malfunction or failure of the product.
